THE DEPUTY MINISTER IN THE MINISTRY OF SHIPPING AND TRANS-PORT (SHRI DALBIR SINGH): (a) and (b) The State of Uttar Pradesh has 10 National Highways totalling in length to 2,328 Kms. No new road of the State was declared as a national Highway in the Fourth Plan period. Also no new road of the State has been declared as such till now in the Fifth Five Year Plan, The 10 national highways are existing roads and do not have any missing link. These are, however being widened, strengthened and 'IMemorandum of demands by Chas Bokaro improved at an estimated cost of about Rs. 45 crores to meet the demand of traffic of the near future. The improvement works include construction of new bridges over the river Ganga at Kanpur on National Highway No. 25 and at Allahabad bridge over the river Yamuna at Kalpi on National Highway No. 25. These improvement works are in various stages of progress. Funds permitting, of there is shortage, the improvement works are likely to be completed by end of the Fifth Plan period.

## Mini Steel Plants
