

(ii) The employees should cooperate with the management in eliminating wasteful work practices and thereby improving productivity and efficiency,

(c) The loss suffered by the Corporation during the period of the lock-out and till the date of resumption of normal operations was Rs. 377 lakhs.

(d) The two employees, who are still locked out, are (i) a Traffic Assistant, who was granted leave upto 25-11-73 and provided with a complimentary passage to U. S. A., and has not yet resumed duty and (ii) an Accounts Superintendent, who is the General Secretary of Air Corporations Employees' Union, the only Union which is yet to reach a settlement with the management of the Corporation on the lines of those signed by all other Unions/Associations despite the fact that all the employees represented by Air Corporations Employees' Union, including its President and about 100 office bearers, had signed individual undertakings and resumed duty.
