- (ii) The employees should cooperate with the management in eliminating wasteful work practices and thereby improving productivity and efficiency,
- (c) The loss suffered by the Cor poration during the period the lock-out and till the date resu mption of normal operations was Rs. 377 lakhs.
- (d) The two employees, who are still locked out, are (i) a Traffic Assistant, who was granted leave upto 25-11-73 and provided with a complimentary passage to U. and has not yet resumed duty (ii) an Accounts Superintendent, is the General Secretary of Air Cor porations Employees' Union, the Union which is yet to reach a settle ment with the management of the Corporation on the lines of those signed by all other Unions/Associa tions despite the fact that all the employees represented Air by Cor porations Employees' Union, includ ing its President and about 100 office bearers, had signed individual under takings and resumed duty.
