(c) what measures are being taken to ensure remunerative prices to the cotton growers?

THE MINISTER OF COMMERCE (PROF. D. P. CHATTOPA-DHYAYA): (a) Kapas prices during the season ending August 31, 1975 registered a decline as compared to the previous season mainly due to higher production.

- (b) 1975-76 cotton season started on 1st September 1975 but the arrivals have been delayed due to late rains. Therefore, it is too early to make any comparative analysis about price behaviour.
- (c) Support prices have already been announced by the Government for the principal varieties of cotton, for the 1975-76 season. Market prices are ruling higher than these support prices and no special measures are envisaged.

Carpet Weaving Training Centres of All India Handicrafts Board

- (a) the total number of Carpet Weaving Training Centres run by the All India Handicrafts Board functioning in the country;
- (b) whether Government propose to set up such Centres in the States of Haryana, Punjab and Himachal Pradesh with a view to boost the export of carpets; and
- (c) if so, by when these Centres are likely to be set up?

 THE DEPUTY MINISTER IN THE

MINISTRY OF COMMERCE (SHRI VISHWANATH PRATAP SINGH):
(a) At present 16 Carpet Weaving Training Centres are being run by the All India Handicrafts Board. Sanction for opening thirty more such Centres by them during the year 1975-76 has already been issued.

(b) and (c). In the first instance Centres for the training of carpet weavers are being set up in the States where carpet weaving has been traditionally practised and from which the bulk of the exports of carpets is taking place. After this stage has been completed, the opening of such Centres in other States including Haryana, Punjab and Himachal Pradesh will be taken up by the All India Handicrafts Board.
