(c) In order to reduce the incidence of accidents at level crossings, various measures have been taken such as provision oof cautionary road signs, 'Stop Boards' to warn the road users of unmanned level crossings ahead; provision of 'Whistle Boards' at unmanned level crossings and also at manned level crossings where visibility is restricted, enjoining upon ihv train drivers to whistle; periodical census of traffic to determine the need for manning or upgrading of the level crossings; educative campaigns am»nj; road users through leaflets, cinema slides, announcements on loudspeakers, radio talks, personal contacts with drivers and transport associations; surprise checks at level crossings etc. Most of the State Governments have legislated under the Motor Vehicle Rules to make it obligatory on the part of the drivers of motor vehicles to stop short of unmanned level crossings and only then cross the railway track with the conductor walking ahead. Checks are also conducted in coordination with police authorities to ensure rigid compliance with the Motor Vehicle Rules by the road users. All State Governments and Union Administrations have also been requested to strictly enforce the provisions of Motor Vehicle Rules; inscribe the word "Danger" on the top of road signs provided at the approaches to all level crossings and provide speed-breakers (bumps) on the approach roads to all level crossings.
