THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI H. R. GOKHALE): (a) to (c) A comprehensive Bill to amend the Election laws entitled "The Representation of the People (Amendment) Bill, 1973", based mainly on the recommendations contained in the Report of ihe Joint Committee on amendments to Election, Law, was introduced in the Lok Sabha on the 20th December, 1973 and is pending consideration in that House.

Certain amendments to the Eelection laws, which were of an urgent nature have, since been made by the Representation of the People (Amendment) Act, 1974 and the Election Laws (Amendment) Act 1975. Some amendments of a procedural nature was also made in May, 1975. in the Conduct of Elections Rules, 1961, by the Conduct of Elections (Amendment) Rules, 1975 and the Conduct of Elections (Second Amendment) Rules, 1975.

Notices to Newspapers on Prices

*269. SHRI BHOLA PRASAD : SHRI RABI RAY : SHRI BIR CHANDRA DEB BARMAN :

Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to state:

(a) whether it is a fact that notices have been issued to some daily Newspapers as per M.R.T.P. Act so as not to increase their price, if so, the names thereof; and

(b) the details of the notices issued?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI H. R. GOKHALE): (a) and (b) The M.R.T.P. Commission has stated that it has not issued notices to newspapers asking them not to increase their prices. However, four notices of inquiry under section 10(a)(iv) of the M.R.T.P. Act, 1969 were issued by it on 26th August, 1975 to some newspaper companies and others in respect of certain trade practices alleged to be indulged in by them and involving "Common pricing by acting in concert". A statement is laid giving particulars of the newspaper undertakings and others to which the notices were issued by the commission.

While the proceedings are still in progress in the Restrictive Trade Practices inquiry Nos. 46 and 47 of 1975, the respondents in the inquiry Nos. 48 and 49 of 1975 have submitted to the Commission's orders passed on 18th December, 1975. restraining and prohibiting them from acting in concert between themselves and with others in the matter of fixing; or increasing the prices of newspapers published by them.
