(c) and (d) An expenditure of Rs. 257.59 lakhs has been incurded in the Central Sector till 31-12-1975 towards the completion of the first phase of the Kovalam beach resort project. The nature and scope of additional facilities to be provided at Kovalam will be determined after the response to the facilities already provided has been assessed in order to ensure economic viability of any new facilities that are to be provided.

## Consumption loans to the rural poor

411. SHRI DEORAO PATIL: Will the Minister of FINANCE be pleased to state the total amount of consumption loans given by nationalised banks to the rural poor during the last year and the current financial year?

THE MINISTER CF STATE IN CHARGE OF DEPARTMENT OF RE-VENUE AND BANKING (SHRI PRANAB MUKHERJEE): There is no statistical classification of bank advances for agriculture as consumption loans and loans for other purposes and hence it is difficult to give the data required.

However, it may be mentioned that there is an element of consumption-finance included in the scale of finance in respect of all crop loans.
