## Loss in the Heavy Engineering Corporation

- 571. SHRI BHAIYA RAM MUNDA: Will the Minister of INDUSTRY AND CIVIL SUPPLIES be pleased to state:
- (a) whether it is a fact that Heavy Engineering Corporation, Ranchi is still running at heavy loss; and
- (b) if so, what steps Government propose to take to streamline the working of the Corporation?

THE MINISTER OF INDUSTRY AND CIVIL SUPPLIES (SHRI T. A. PAI): (a) The Heavy Engineering Corporation had been running at a loss till 1974-75. The loss during 1974-75 was substantially less than the loss of the previous year. During the current year H.E.C. expects to break even.

(b) The financial operations of the Company will significantly improve with the increase in production. a number of steps, including the follow ing, have been taken to streamline the working of the Corporation and to improduction: installation balancing facilities; introduction of an effective system of production planning and control; introduction of a systematic maintenance/preventive maintenance scheme; better inventory control; improvement in the liquidity of the Company; professionalisation of the top management.
