# 63 Written Answers

Sentinalese:—Two expeditions to the North Sentinel island have been made so far. One was in March, 1973 and the second in March, 1974. During the first expedition some Sentinalese were sighted and the expedition dropped gifts on the shore. The second expedition was more successful than the first in the sense that the Sentinalese allowed the party to drop the gifts within their sight and by gestures made it clear that they would like to have more gifts.

The Administration propose to continue with their policy of establishing contact<sub>s</sub> and be-friending both these hostile tribes.

#### Levying of salt cess

537. SHRI RAMLAL PARIKH: Will -the Minister of INDUSTRY AND CIVIL SUPPLIES be pleased to state:

(a) the reasons for levying the salt •cess on salt producers who manufacture salt on more than 100 acres of land;

(b) what amount has been paid by Gujarat to the Central Government -during 1961 to 1974; and

(c) the amount spent by the Central Government during the Third and Fourth Five Year Plan periods for the general development of the salt industry and for the labour welfare in Gujarat?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY AND CIVIL SUPPLIES (SHRI B. P. MAURYA): (a) Cess is levied on salt under the Salt Cess Act, 1953 (No. 49 of 1953) for the purpose of raising funds to meet the expenses incurred on the salt organisation maintained by Government and on the measures taken by Government in •connection with the manufacture, supply and distribution of salt.

(b) and (c) Amount of cess collected and expenditure incurred therefrom on general development and labour welfare activities was not kept State-wise. However, figures for the year 1969-70 to 1974-75 are give<sub>n</sub> in the attached Statement.
