

(i) The National Agricultural Co-operative Marketing Federation Ltd., has been requested to explore the possibility of purchasing potato for export purpose from LLP.

(ii) The assessment of the requirement of railway wagons for quick movement of potatoes has been made in consultation with the U.P. Government and the demand position intimated to the Railway Board. The Railway Board have issued instructions to North Eastern Railway and Northern Railway to supply adequate number of wagons to the concerned stations during the season.

(iii) The State Government is making all efforts to establish more cold storages in private and Cooperative Sectors in the State.

(iv) The Government are also considering a scheme of commercial purchase of limited quantities of potatoes by F.C.I. in the main producing districts of U.P.

(v) The Government are also exploring the possibility of export of potatoes.
