help colleges in strengthening their faculty. in improving their library and laboratory facilities and in providing them with workshop and other similar facilities to enable them to achieve and maintain proper standards. The conditions laid down to enable the colleges to take advantage of the assistance from the Commission during the Fifth Plan period inter-alia provide that there should be a minimum enrolment of 400 students excluding pre-uni; versity/predegree/intermediate classes and staff of at least 20 suitably qualified permanent teachers. In the case of colleges providing two-year degree courses the minimum required enrolment will be 270 and at least 15 suitably qualified permanent teachers.

Development work in Jama Masjrl area in Delhi

- THE MINISTER OF WORKS AND HOUSING (SHRI K. RAGHURAM-AIAH): (a) The redevelopment plan for the area around Jama Masjid is already under execution. At present there is no scheme for development of Matia Mahal

and Sir Syed Ahmad Road areas. Pha-tak Kucha Chelan forms a part of Delhi Ajmeri Gate redevelopment scheme and a proposal for development of this area is under consideration.

- (b) and (c) The redevelopment scheme rn respect of Jama Masjid complex is being executed in three phases as follows:—
 - (i) Landscaping of a formal garden in parade ground area;
 - (ii) construction of 48 basement shops; and
 - (.hi) development of garden/piaza around Jama Masjid.

The first phase is already complete. Construction of 24 shops out of 48 is also complete and the construction of another 24 shops is in hand. Development of garden/piaza around Jama Masjid has been carried out but it will be developed further.
