The composition of a Selection Committee is related to the nature of a patricular category. Normally, there is a departmental representative and outside experts who constitute the Selection Committee.

Scheme to help the families of low paid Government employees

738. SHRI AWADHESHWAR PRASAD SINHA: Will the PRIME MINISTER te pleased to state:

- (a) Whether Government have formulated any scheme for giving training in tailoring and sewing to help the families of low-paid Central Government employees; and
 - (b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF PERSONNEL AND ADMINISTRATIVE REFORMS (SHRI OM MEHTA): (a) and (b) Government are already operating a scheme of imparting training in cutting, tailoring and embroidery to families of Central Government employees. The scheme was first started in 1957 and is being run through the Grih Kalyan Kendra, a Wing of the Staff Welfare Organisation of the partment of Personnel and Administrative Reforms. The training is conducted 55 centres situated in Delhi, Bombay, Madras and six other places. A nominal fee of Rs. 3 per mensem is charged from families of class IV employees and Rs. 6 per mensem from others. The intention of the scheme is to help these families to utilise their leisure hours gainfully as well as to enable them to supplement their family income with the skill gained as a result of the training. Those womenfolk as are willing to undertake stitching of liveries for Government staff are permitted to work in the production centres of the Grih Kalyan Kendra at New Delhi. Madras and Dehra Dun.

Shortage of cement and iron in Manipur

- 739. SHRI I. TOMPOK SINGH: Will the Minister of INDUSTRY AND CIVIL SUPPLIES be pleased to state:

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY AND CIVIL SUPPLIES (SHRI B. P. MAURYA): (a) and (b) Against a quantity of 156,970 tonnes of cement supplied during 1974 to Manipur and the North Eastern Zone, supplies to the extent of 262,000 tonnes were made during the year 1975. No complaint has been received from this Zone about short supply of ament. Bottlenecks in transporting stocks allocated to this area were however noticed occasionally.

As regards iron, it has been reported that the availability of mild steel bars and ods which are mainly used in construction work, was higher than the actual demand during 1975. However, it is understood that no statistics regarding supply and demand of mild steel bars and rods are maintained areawise.
