Will the Minister of COMMUNICA-TIONS be pleased to state (a) whether it is a fact that the Okhla Telephone Exchange has been provided with additional telephone lines; and

(b) if so, whether the total requirements of pending requests for telephone connections and the additional requirements for Nehru Place and other centres in the area are likely to be met thereby?

THE MINISTER OF COMMUNICATIONS (SHRI S. D. SHARMA): (a) Yes, Sir. Recently on 3-1-76, 800 lines have been added to the Okhla Exchange raising its capacity to 4,100 lines.

(b) This additional capacity will partly meet the pending requests for telephone connections and the additional requirements for Nehru Place and other centres in the area.

in his capacity as Chairman of the Near East and South Asia Sub-Committee of the U.S. Senate Foreign Relations Committee, He called on the Prime Minister, Foreign Minister and Minister of Agriculture.

(b) and (c) No, Sir. These discussions centred on bilateral and international issues of mutual interest with a view to promoting better understanding between India and the United States. However, the question of the role of foreign forces and the danger of external intervention in this region came up for discussion in a general way.
