#### **Improvement of Roads under Special Area Development Programme**

\*506. SHRI S. KUMARAN-. Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

(a) whether the Kerala Government have requested the Central Government to include the scheme for improvement and widening of five roads in the "Special Area Development Programme for the purpose of Kerala Newsprint Project at Vellore; and

(b) if so, the details thereof and Government's decision thereon?

THE MINISTER OF SHIPPING AND TRANSPORT (DR. G. S. DHILLON): (a) and (b) Yes, Sir. The Kerala Government have requested for Central financial assistance for Rs. 2.11 crores for the following five roads:—

- (1) Ettumanur-Ernakulam Road.
- (2) Thalayolaparambu-Kuthattukulam Road (upto Moorkattipadi).
- (3) Ambanthanam-Kallungal Kadavu Road.
- (4) K. K. Road from Km. 57 to Km. 110.

(5) Road connecting Ernakulam to the Project site via Mulan-thuruthi-Thalapara junctions No decision has yet been taken.
