(ii) Foreign incorporated companies as well as Indian companies having foreign holding of more than 40 per cent are required to obtain the approval of the R. B. I. for entering into new lines of business, carrying on their existing activities etc. Committee on Drugs and Pharmaceuticals which submitted its report on 6th April, 1975 have also looked into various aspects of drug industry. A copy of the report was laid on the Table of the House on the 8th May, 1975. Government will take a view on the various aspects in the totality of recommendations of the Committee.
