THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PRA-NAB MUKHERJEE): Sir, in the reply to Unstarred Ouestion No. 1583, it was stated inter alia that the transfers of Class 11. Ill and IV officers are restricted to the jurisdiction of the Heads of Departments under whom they are working. It has been found that through an oversight the position has not been correctly stated in regard to Income-tax Officers, Class II. who, in exigencies of service, are liable to be transferred from one Commissioner's charge to another in the same zone. Foi this purpose, the Commissioners' charges have been divided into five zones. Such transfers may normally be made after a stay of 6 years in a Commissioner's charge except at Bombay and Calcutta where the period of stay may be 7 years.
