**CBI investigation against the officials of the Office of Chief Engineer (C.D.O.), C.P.W.D., Nirman Bhavan, New Delhi**

**429. SHRI SUBRAMANIAN SWAMY :** Will the Minister of WORKS AND HOUSING be pleased to state :

(a) whether C. B. I. has investigated cases of fraud, forgery and cheating regarding :—(1) Universal Book Traders, Ganeshnagar, Tilaknagar, Delhi, (2) International Book Traders, Model Town, Delhi, (3) Venus Book Company, Delhi, (4) Universal Book Dealers, Delhi and (5) Modern Book Centre, Delhi, involving a librarian Shri Daryao Singh and other senior officials of the Office of the Chief Engineer, Central Design Organisation, C.P.W.D., Nirman Bhawan, New Delhi; and

(b) if so, when the case was registered, what are the findings of the investigation and the follow-up action?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUSING (SHRI DALBIR SINGH): (a) and (b) C.B.I. have registered two cases in the matter in the latter half of 1972 and are making investigations.

**Agitation in I.I.T., New Delhi**

(a) whether there was an agitation by the employees during the latter half of 1974 in the Indian Institute of Technology, New Delhi; and

(b) if so, what were their grievances?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN) : (a) and (b) According to the information furnished by the Indian Institute of Technology, Delhi, there was no agitation by the employees of the Institute. However,

some daily-wage workers of the Institute who are not employees started an agitation during the latter half of 1974. Their main demand was that they should be absorbed in the regular cadre.

**Litigation cases of B.H.U.**

NURUL HASAN) : According to the information furnished by the Banaras Hindu University, the number of litigation cases in which the University was involved and the amount of expenditure booked on them during the tenure of the present Vice-Chancellor is 73 and Rs. 29,446.79 respectively.
