(b) if the answer to part (a) above be in the negative, the amount spent in Uttar Pradesh as T.A./D.A. etc., on such transfer and number of persons those affected;

(c) if the answer to part (a) be in the affirmative, the amount spent on TA/DA etc. and the action Government have taken or propose to take for flouting Orders and to save avoidable wastage to the national exchequer; jTid

(d) whether Government propose to continue the ban during 1975-76 to effect economy?

(d) Orders have been issued by (he Ministry of Finance for continuance of the ban during 1975-76 also.
