THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PRANAB MUKHERJEE): (a) to (d) A statement is laid on the Table of the House.

#### Statement

(a) Three companies and 19 directors Principal Officers are involved in the 407 prosecutions which have been filed in the 'Bajoria Jalan Group' of cases. The proceedings at Calcutta in respect of 371 prosecutions have been stayed by the Chief Metropolitan Magistrate as a result of writ petition challenging that Directors of Companies are not the Principal Officers. In addition, an ap plication has been moved that all the prosecutijons may be centralised with one trial Magistrate.

Two of the 36 prosecution applications filed at Bombay have been dismissed by the Chief Metropolitan Magistrate. Against these, revision petitions are being filed before the Bombay High Court.

(b) and (c) 90 writ petitions have been filed in 'Birla Group' of cases. On the admission of the writ petitions by the respective High Courts and the issue of the Rule Nisi, interim stay of proceed ings was ordered pending determination by the Courts whether assessment/reas sessment proceedings were initiated va- I lidly and with proper jurisdiction. In I order to have the question of jurisdic tion settled expeditiously, an application was moved in a representative case for hearing the cases by a Division Bench. The prayer has since been granted and the case is now posted for hearing on 19-5-75 before a Division Bench of the Calcutta High Courf.

(d) The Special Cell are investigating the Shriyans Prasad Jain Group known as 'Sahu Group'. The investigations are in progress.

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PRANAB MUKHERJEE): (a) to (c) No proposal to make selections for promotion to posts of Assistant Commissioners of Income-tax, is at present under consideration. When such a proposal is taken up for consideration, the relevant orders of the Government providing for concessions in favour of Scheduled Castes and Scheduled Tribes officers will, as in the past, be duly kept in view. The concessions provided in the matter of selections for promotion posts" of Assistant to do not include any Commissioners, reservation on percentage basis in favour of Scheduled Castes and Scheduled Tribes.

- (c) Since the report was prepared for the internal use of the World Bank, the question of a Government decision on it does not arise. It is, however, the Government's policy to make optimum use of its available energy resources.
