and departure of trains and social education to passengers. Spare time available will be utilised for commercial advertisements.

(c) Close circuit television has already been installed at Madras Central.

There are no concrete proposal, at present, for installation of closed circuit television at any other Railway Station in the country.

- (c) No, Sir. The Bureau of Industrial Costs and Prices have, however, undertaken a techno-economic study of the synthetic detergent industry which is in progress.

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI H. R. GOKHALE): (a) The information as on 31-3-1975 is not available. However, 95,729 cases were pending in Allahabad High Court as on 31-12-1974.

- (c) The State authorities have been advised to review and refix the Judges strength of the High Court in order to clear the pending cases. The Chief Justice of the High Court is regularly reviewing the pendency of cases and by constituting special benches, taking up of group of cases involving similar points of Law, disposal of cases is being expedited.
