

(e) if so, whether Government propose to reconsider their decision to extend subsidy for exports and to take action against textile mills and compel them to reduce the cloth prices ?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI VISHWANATH PRATAP SINGH) : (a) and (b) The current prices of cotton textiles in the country are higher than the ruling international prices by 15 to 20%.

(e) Government have no proposal to subsidise cotton textile exports. However, Government have recently agreed to make a contribution at the rate of 5% of the f.o.b. value of exports of cotton textiles from the country (excluding cotton piece, goods and cotton yarn) to cover the cost of internal non-refundable taxes duties etc.

(&) The fall in cotton prices has started only recently, and it is too early for this to be reflected in the prices; of cotton textiles. Even then there has been some fall in the prices of cotton textiles Government are watching the situation to see whether any action is required to be taken.

(e) As no subsidy is being paid, this question does not arise.
