Insured Letters and Boxes were concluded at Dacca on 27th November, 1974. These Agreements provide for inland postage rates for unregistered letters and insured letters and boxes. Copies of the Agreements are placed on the Table of the Rajya Sabha. [See Appendix XC, An-nexure No. 88] There is no change in the postal arrangements as a result of the execution of these Agreements and these only seek to confirm and legalise the *ad* hoc arrangements being followed in respect of mail arrangements between the two countries after the liberation of Bangladesh.
