CALLING ATTENTION TO MATTER F URGENT PUBLIC IMPORTANCE

Reported sharp fall in raw jute prices MR. CHAIRMAN: Calling Attention Motion. Shri Niren Ghojfh,

SHRI NIREN GHOSH (West Bengal): Sir, I beg to call the attention of the Minister of Commerce to the reported sharp fall, in the prices of raw jute resulting in its distress sale affecting jute growers In West Bengal, Assam, Orissa. Tripura. Meghalaya and Bihar.

THE MINISTER OF COMMERCE (PROF. D. P. CHATTOPADHYAYA)

Mr. Chairman. Sir. some Hon'ble Members have drown Government's attention to the reported decline in prices in almost all the jute growing States in Eastern India thereby affecting the growers. It has also been alleged that there have been distress sales of raw jute in the jute growing States. A study of the behaviour of pi ices of raw I jute in the open markets particularly in the up country markets would show that there has not been such a sharp decline in the prices of raw jute as would have an impact on the growers. I would also like to state . that we have no reports of distress sales | by the jute growers and on the contrary, except in the case of Tripura. the growers in general have been obtaining prices above the minimum support prices and the levels of the previous year.

It is the constant endeavour of Government to safeguard the grower's interests and ensure that the grower is in a position to get remunerative prices for his produce. Government fully appreciates the difficulties caused to the grower by violent fluctuations in prices of raw jute and our efforts are directed to ensure a reasonable stability in jute prices. Government has, theretore been keeping a close watch on the trends In prices in all the markets oarticularly in the remoter pockets and I can assure the ! Hon'ble Members that the machinery available with the Government will be fully utilised for the contraction of the state of the ensuring that the basic objec-I tive of safeguarding the interests of the ! grower is as far as possible taken care of. At the same time. Government has to see to it that the prices do not reach such unconscionable levels as to undermine the competitiveness of our export products and it is in this light that the twin objective of providing a fair price to the grower on the one hand and ensuring the competitiveness in the inlernational markets of o'ir products has to be borne in mind.

On the recommendations of the Agricultural Prices Commission. Government had fixed a minimum support Dnce on a statutory basis, for Assam Bottom variety of raw jute at Rs. 125/- ner quintal in the upcountry market.
