(d) The posts of Upper Division CUjrks in the Commission are filled 100 per cent by promotion of Lower Division Clerks of the Commission with 5 years service in the grade, failing which by transfer/deputation of persons serving under the Central Government. All the existing posts of Upper Division Clerk in the Commission have been filled by the promotion of Lower Division Clerks in the Commission.

(e) The posts of Upper Division Clerk in the Commission are filled by promotions from the grade of Lower Division Clerks in the Commission on the basis of seniority-aw;-fitness, after taking into account the relevant instructions of Government relating to reservation for Scheduled Castes/Tribes.]

Hike in drug prices

409. DR. Z. A. AHMAD : Will the Minister of PETROLEUM AND CHEMICALS be pleased to state :

(a) whether it is a fact that his Ministry has received requests from drug manufacturers for an immediate hike in drug prices ; and

(b) if so, what are the details of the requests made and what is Government's decision thereon?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI K. R. GANESH) : (a) and (b) The Drugs (Price Control) Order, 1970 provides a mechanism for revision of prices. Consequent upon the^ petroleum crisis during the second half of 1973-74, prices of a large number of chemicals including bulk drugs increased, with the result that the number of applications received from the drug manufacturers for revision of prices of their products also increased very considerably. These applications are examined in accordance with the provisions of the Drugs (Prices Control) Order, 1970 by a Committee constituted under the Bureau of Industrial Costs and Prices. A large number of these applica-

tions have been scrutinised and Government have issued appropriate orders therein upon.
