- (d) No Sir. During the years 1971 and 1972 they are reported to have expected small quantities of Metranidazole in the form of bulk drug.
- (e) Since the company are manufacturing a wide range of bulk drugs and formulations and many of the operations of manufacture are common and carried on in a composite plant, it is not possible to calculate precisely the profits from this activity alone.

The gross profits before taxation earned by the company during the last three years were as under:

> 1969-70 . . . Rs. 109.46 lakhs 1970-71 . . . Rs. 121 lakhs 1971-72 . . . Rs. 125.36 lakhs.

Import of the formulations of Metronidazole is not permitted. Based on the statistics maintained by the DGHS Metronidazole was imported at an average CIF price of Rs. 125 per kg. during 1973-74; the indigenous price of Metronidazole bulk is Rs. 794.73 per kg.
