- *316. SHRI B. D. BARMAN: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI SHAH NAWAZ KHAN): (a) No, Sir. Excise duty at 20 per cent and 37½ per cent ad valorem continues to be leviable on levy and free sale sugar respectively since 15-12-1973.

Statement

(a) and (d) A proposal for constituting a high power National Water Resources Council to evolve a national water policy and guide its implementation and to resolve inter-State water disputes expeditiously has been under consideration for some time. As a

first step, proposals to amend some provisions in the Constitution referred to the State Governments for their comments. While a few States expressed themselves against amendments, most of the States felt that the scope of the amendments should be limited to disputes on inter-State waters only and that the existing powers of the States in regard to the use and control of water should continue as heretofore. The matter is under further study in the light of the views expressed by the State Governments.
