### Loans Sanctioned by the Agricultural Refinance Corporation

\*457. SHRI BABUBHAI M. CHINAI: Will the Minister of AGRI-AND IRRIGATION CULTURE pleased to state:

- (a) the amount of loans sanctioned by the Agricultural Refinance Corporation in various States during the last one year; and
- (b) what is the nature of imposed to ensure that the funds are utilised for the purpose for which loans were given?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI SHAH NAWAZ KHAN): (a) 550 schemes involving financial outlay of Rs. 251.34 crores of which Agricultural Refinance Corporation's commitment is of the order of Rs. 220.47 crores were sanctioned during 1973-74 to various States.

(b) The financing institutions expected to supervise the end use of the loans sanctioned by them including those refinanced by the Agricultural Refinance Corporation. ever, the Agricultural Refinance Corporation also through its staff undertakes verification of the utilisation of the loans by the borrowers on a sample basis and its findings are communicated to the financing institutions appropriate action.

(a) whether it is a fact that the New Delhi Municipal Committee has pressed into service a few buses for operation within the NDMC area; and

(b) if so, what is the operational benefit and the total investment made by N.D.M.C. in procuring these buses?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS & HOUS-ING (SHRI MOHAN DHARIA): (a) Yes, Sir.

(b) The introduction of these buses by the New Delhi Municipal mittee, has provided an efficient additional transport facility to a number of commuters to and from their places of work and has augmented the public transport service in Delhi under Delhi Transport Corporation to some extent. The total investment made by the New Delhi Municipal Committee in procuring these buses is Rs. 11.00 lakhs.

- (a) the progress so far made in regard to the Tehri Dam Project;
- (b) by when it is scheduled to be completed; and
- (c) the expenditure likely to be incurred thereon by the Central and the State Governments, separately?]

कृषि स्रौर सिंचाई मंत्रालय में उपमंत्री (श्री केदार नाथ सिंह) : (क) से (ग) विवरण सभा पटल पर रखा जाता है।

### विवरण

- (क) टिह्री परियोजना से सम्बद्ध निर्माण-पूर्व अन्वेषण कार्य, विभिन्न संरचनाओं के ले-आउट तथा अभिकत्यों को अंतिम रूप देना, मड़कों तथा कालोनियों कार्य निर्माण तथा व्यपवर्तन के लिए खुदाई कार्य प्रगति पर है।
- (ख) परियोजना प्राधिकारियों द्वारा तैयार किए गए कार्यक्रम के म्रनुसार परियोजना को पूर्ण करने में, कार्य ग्रारम्भ करने की तिथि से लगभग 12 के वर्ग लगेंगे।
- (ग) परियोजना की अनुमानित लागत (जल वितरण प्रणाली को छोड़ कर) 197. 9<sup>2</sup> करोड़ रुपये है। इस परियोजना पर उतर प्रदेश सरकार धन लगा रही है।

#### Statement

- (a) Work on pre-construction investigations, finalisation of layout and designs of various structures concerned with Tehri Project, construction of roads and colonies, and excavation for diversions is in progress.
- (b) As per programme prepared by the project authorities it will take about 12½ years to complete the project from the date of commencement of works.
- (c) The estimated cost of the project is Rs. 197.92 crores (excluding water distribution system). The project is being financed by the Uttar Pradesh Government.]

### Migration of farmers and labourers on account of starvation in Eastern Madhya Pradesh

\*460. SHRI SAWAISINGH SISODIA: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

- (a) whether it is a fact that thousands of farmers and landless labourers from eastern Madhya Pradesh are migrating to other places to escape starvation; and
- (b) if so, the steps taken by Government to check the migration?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI ANNASAHEB P. SHINDE): (a) No. Sir. However some people of Eastern Madhya Pradesh traditionally go out to other parts of the country every year to do earthwork on various projects.

(b) In order to relieve the distress caused by the scarcity conditions which have developed in parts of the State as a result of the failure of the monsoon this year the State Government have opened 1,272 scarcity works which has given employment to about 1,88,000 persons.
