THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) and (b) Government have provided licences and letters of intent to a number of parties in West Bengal in recent years for manufacture of several electronic items. Expansion of the existing units is also being permitted according to the policy guidelines laid down by Government.

(c) and (d) A statement showing the applications received for the manufacture of Magnetic Tapes is enclosed together with the decisions taken on them. No other applications for this term now pending with Government.
