(a) whether it is a fact that the Ganesh Electrical Fan Unit of the Ganesh Flour Mills Co. Ltd., Delhi has not started working ever since its take-over

(b) whether it is also a fact that because of delay in starting the Unit, hundreds of workers are put to great hardship;

(c) whether Government have received any representation or memorandum requesting for an early recommissionins of the LTnit; and

(d) if so, what steps have been taken so far to reopen the Unit ?

THE MINISTER OF STATE IN THF MINISTRY OF INDUSTRY AND CIVIL SUPPLIES (SHRI B. P. MAURYA)

(a) Yes, Sir.

(b) and (c) Representations have been received urging early recommissioning of the unit, in view of the hardship caused to the former employees by closure of the Unit.

(d) The Management Committee of the Undertaking have been hampered in their effoits to re-start the unit on account of certain constraints relating, *inter alia*, to insufficient usable machinery available in the unit, difficulty in obtaining working capital and difficult market conditions for fans. The Committee are, however, expiring ways and means to utilize the existing fan unit to the best advantage of the company.
