The National Industrial Development Corporation, a public sector consultancy firm, has provided assistance for projects such as an Industrial Estate, a Billet Casting Unit and for the manufacture of farm implements, machine tools, steel, sheet glass and sugar. We have also extended a loan to Tanzania for a sum of Rs. 5 crores for industrial development.]

## Manufacture of plant nutrients by Hindustan Copper Ltd.

- (a) whether it is a fact that Hindustan Copper Ltd. and Hindustan Zinc Ltd. have started manufacture of plant nutrients as by-products;
  - (b) if so, the details thereof;
- (c) what is the expenditure incurred in marketing the plant nutrient products; and
- (d) whether Government propose to undertake the sale of the plant nutrients through public sector agencies and cooperatives?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUKHDEV PRASAD): (a) Hindustan Copper Limited: Hindustan Copper Ltd. is setting up a plant for the production of about 2 lakh tonnes of Triple-Super-Phosphate. The Plant is under construction and is likely to be commissioned by March, 1975.

Hindustan Zinc Limited: The Hindustan Zinc Ltd., Udaipur, has been manufacturing Single Super Phosphate in its zinc smelter at Debari (near Udaipur) utilising by-product sulphuric acid. The company has also been manufacturing zinc sulphate mainly for captive consumption.

(b) Hindustan Copper Limited: Does not arise.
