

**Percentage of occupancy of berths in A.C.C. coaches**

1173. SHRI JAGDISH PRASAD MATHUR: Will the Minister of RAILWAYS be pleased to state:

(a) what is the percentage of occupancy of berths in A.C.C. Coaches from Delhi to Jaipur and Ahmedabad and vice versa in the month of November, 1974;

(b) whether it is a fact that accordin to present needs only one A.C.C. Coach in train is sufficient;

(c) whether it is also a fact that there is a regular long waiting list of I Class passengers at Jaipur Station; and

(d) if so, whether Government propose to provide one full first class coach at Jaipur instead of a Combined A.C.C. and I Class Coach ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SARDAR BUTA SINGH) (a) The percentage occupation of Air-conditioned accommodation during November 1974 was as under:

- (i) Delhi-Jaipur coach—37%
- (ii) 'Delhi-Ahmedabad coach—52%
- (iii) Jaipur-Delhi coach—50%
- (iv) Ahmedabad-Delhi coach—57%

(b) to (d). The proposal to withdraw the Delhi-Jaipur Air-Conditioned-cum-First composite coach is under active consideration and if found justified, necessary change in the composition of the train will be made.

(c) Yes.

Optimize Traffic Revenues.

Maximise productivity and productivity gains through better supervision control and organisation.

Economise in consumption of Stows & Fuel through effective management and improved techniques.

Boost ancillary earnings by faster disposal of scrape and reclamation of waste.
