#### Export of raw jute

Will the Minister of COMMERCE be pleased to state:

(a) whether it is a fact that a section of jute mill owners have made a move at high levels not only for banning exports of raw jute but also for large scale imports of the fibre ;

(b) whether it is also a fact that the mill owners wish to bring down the raw jute price in primary market and thereby deprive the jute growers of their due share; and

(c) whether mill owners are getting tacit support from certain section of officials at different levels in Government.

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI V. P. SINGH): (a) to (c) A proposal in this regard had been received from the industry mainly with a view to ensuring adequate availability of raw jute at the end of the current season in view of the short crop. Since ensuring adequate raw material is necessary, some imports from Bangladesh are being undertaken.

Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) what are the reasons for Air India to send some of its West-bound services from Bombay to Delhi thus burning fuel for two hours for which the public pays;

(b) what are the reasons for closing down the international air terminal at Dum Dum where a considerable amount has been spent very recently to renovate the whole place and for what other purposes they are going to utilise this space; and

(c) whether it is a fact that a deliberate attempt is being made to curtail the space in the international terminal building in the hope that it will never handle Jumbo Jet and it will not be allowed permanently to handle any direct West-bound Air India flight without a change over at Bombay or Delhi ?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI RAJ BAHADUR

(a) Air India operates three of its 747 services to USA and one UK terminator via Delhi. The inclusion of Delhi in the route is guided by commercial considerations as Delhi generates about fifty percent of the UK/USA traffic originating/disenbarking in India thus making it important for Air India to serve Delhi on its West bound flights. Besides, passengers bound from Delhi do not generally like to break their journey and change planes at Bombay. There are also direct services from Delhi to points in the West operated by foreign airlines. The additional cost of routing the flights via Delhi is more than compensated by the revenue earned from traffic to/from Delhi. In addition to international traffic, Air-India also carries Indian Airlines overflow traffic between Bombay and Delhi.

(b) Neither the International air terminal nor the domestic air terminal at Dum Dum airport is being closed down. On the basis of traffic projections, the present domestic terminal building would require a good deal of expansion and improvement.
