(c) the reaction of Government thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SARDAR BUTA SINGH): (a) Yes.

(b) and (c) Three new projects falling in Madhya Pradesh having total cost of Rs. 5.24 crores have been in-

cluded in the Budget for 1974-75 and the work on them will be taken up shortly. An outlay of Rs. 55.25 lakhs has been proposed in 1974-75 on these works. A number of other schemes having considerable employment potential are also in progress in that State. Details of important new work* and works in progress in Madhya Pradesh is given as per the attached statement.

Hunger-strike by discharged staff

- (b) whether it is a fact that the discharged staff went on relay hunger strike at Santragachi demanding re-employment; an.)

(c) whether Government propose to reemploy all the discharged staff?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SARDAR BUTA SINGH): (a) The services of about 4850 casual labour/substitutes got discontinued because they took part in aa illegal strike and they had to be deemed as discharged. In addition 2100 permanent and temporary staff of South Eastera Railway had also been removed/dismissed or had their services terminated.

- (b) Yes, Sir.
- (c) About 3050 casual Labour/substitutes have been re-engaged. In addition on consideration of appeals, about 1250 permanent and temporary employees have already been put back to duty. Further appeals are under consideration.

Waiting List for Allotment of Liquified Petroleum Gas in Delhi

- 19. SHRI SHYAMLAL GUPTA: Will the Minister of PETROLEUM AND CHE MICALS be pleased to state:
- (a) whether it is a fact that a large number of persons are on the waiting list for allotment of liquifie^petroleum gas in Delhi;
- fb) if so, the number of persons registered with the different cooking gas producers till the end of October, 1974;
- (c) the average time taken by the producers to supply the gas after registration;
- (d) what steps Government propose to take to ease the situation?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI K. R. GANESH): (a) and (b>'. Number of persons registered upto 31-10-74 for allotment of new In-dane connections in Delhi is approximately 74,500. Other companies are not registering new customers in Delhi for gas connections. However, Hindustan Petroleum Corporation has a waiting list of about 400 persons who have been transferred to Delhi from other Stations.

- (c) Time taken for allotment of gas connection cannot be uniformly determined as it will vary from distributor to distributor and location to location depending upon the total demand in a particular area, commissioning of new distributorships/ dealerships in that area.
- (d) Steps are being taken to improve the availability of LPG cylinders and increase production of LPG at Koyali refinery. LPG will also be produced at Haldia as the refinery goes on stream.

Requirement of Crude Oil

- 20. SHRI SHYAMLAL GUPTA: Will the PETROLEUM of Minister CHEMICALS be pleased to state:
- (a) what is the requirement of crude oil in the country for the next year; and
- (b) how Government propose to meet the requirements?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI K. R. GANESH): (a) and (b). Due to liniited foreign exchange availability, total crude oil, both indigenous and imported, that is likely to be processed in all refineries during 1974-75 is estimated to be about 21 million tonnes.

Requirement for 1975-76, worked out, in the light of the current year's trends in consumption and keeping in view the foreign exchange outgo, is at present under consideration of Government.
