(4) M/s. Modipon Ltd., wherein it was stated that the operation of the agreement results in restrictive trade practices within the meaning of section 2 (0) of the M.R.T.P. Act, 1969. The Commission has also observed that several clauses of the said agreement fall within the category of restrictive trade practices under section 33(1) of the Act

The preliminary issues having been settled the Commission has decided to proceed to final hearings, inter alia, for determination whether the restrictive trade practices found are prejudicial to public interest and as to what orders under section 37(1) will be appropriate? The matter is still under consideration of the Commission.

(b) Does not arise.

### Korba and Paradeep Projects

#### Wagon Industry

for another 14,000 wagons of all types to keep the capacity of wagon industry fully booked for another 3 years; and

(b) if so, the break-up of the orders already pending with each large wagon building company and the extent of fresh orders to be placed with each of them?

THE DEPUTY MINISTER IN THE MI-NISTRY OF RAILWAYS (SHRI BUTA SINGH): (a) Ministry of Railways are not aware of any recession in the Wagon Industry on account of inadequacy of wagon orders. Wagon Industry have already adequate orders which are sufficient to keep their capacity engaged for about three on the basis of their perforthe recent past. Howmance in already ever. orders have been placed for 625 wagons against 1974-75 Rolling Stock Programme; tenders are under finalisation for 1.750 wagons and further tenders have been invited for procurement of 11,711 wagons in terms of four wheelers.
