Written Answers

Government of India had written to the State Governments that the revised pay scales University and College teachers, as recommended by the University Grants Commission, may be implemented. A formal communication regarding the offer of Central assistance for the purpose and other conditions was sent to all the State Governments on November 2, 1974. It is now for the State Governments to formulate their proposals.

Uniform Education System

1341. SHRI B. R. MUNDA: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

(a) whether Government have finally decided to introduce uniform education system,

namely 102+3 to the country in accordance with the national education policy outlined in the Kothari Commission's Report.

- (b) what are the States that have so far adopted the system; and
- (c) by when the system is proposed to be introduced in all the States?

THE DEPUTY MINSITER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) to (c) The matter is primarily the concern of State Governments. The Central Advisory Board of Education on which all State Education Ministers are represented has adopted a resolution recommending that the new pattern of School Education should be introduced throughout the country before the end of the 5th five year plan period.

So far the 12 year pattern of school education consisting of 10 years of primary/secondary education fo'lowed by 2 years of Higher Secondary Education has been introduced in Andhra Pradesh, Kerala, Karnataka and Uttar Pradesh. Assam, West Bengal and Maharashtra have introduced the revise I pattern of Secondary education and are planning to introduce the two-year course at the Higher Secondary stage. Bihar, Gujarat Himachal Pradesh, Jammu & Kashmir, Orissa and Rajasthan are working out the details for the introduction of the new pattern. The other state Governments are considering the matter. The Delhi Administration proposes to introduce the new pattern from May, 1975. Schools in the other Union Territories will adopt the changes made by the respective Boards of Education to which they are affiliated. It is expected that the new pattern will be adopted by all the States/Union Territories during the fifth plan period.
