(a) to (c) The main contribution made bythe Paddy Processing Research Centre consists
in demonstrating the use of Rubber Roll
dehusker and centrifugal type dehusker along
with simple cleaners andpaddy separators for a
smaller milling capacity and restricting the use
of hullers to polishing of rice only. The improved technology is designed to replace the
huller and to produce a higher out-turn of rice
of superior quality, besides bran richer in oil. It
has also developed techniques for the preservation of moist paddy by salt treatment, and

securing higher out-turn in respect of parboiled . rice by the use of Sodium Chromate in the cold water soaking of paddy. These techniques are under evaluation and are being followed up.
