THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PRANAB MUKHERJEE): (i) Number of raids conducted by the incometax authorities in the charges of Commissioners of Income-tax Karnataka during the period 1-4-1974 to 31-10-1974—29.

(ii) Value of assets seized in the above searches (besides incriminating books of account and documents):

### (iii) Action taken in these cases:

Seized materials are under scrutiny. Orders u/s 132 (5) of the Income Tax Act determining the undisclosed income in a summary manner and retaining the seized assets to cover tax liabilities have been passed in three cases. The undisclosed income determined in these three cases aggregates to Rs. 42.22 lakhs. In other cases, where valuable assets have been seized, necessary action in this regard has been initiated.

### Jute prices

Will the Minister of COMMERCE be pleased to state:

- (a) whether Government have taken any steps to prevent the downward trend in the prices of raw jute to protect the interests of growers;
- (b) if so, the details thereof and the results achieved thereby; and
- (c) what is the prevaling price of raw jute in vanous Eastern States?

THE MINISTER OF COMMERCE (PROF. D. P. CHATTOPADHYAYA):
(a) and (b) Prices of raw jute had shown an upward trend till the fourth week of September, but there has since then been a gradual decline which is roughly of the order of 10% to 15% primarily because of increase in arrivals. The prices, however, are still substantially higher than the minimum support price prescribed. Jute Corporation of India has been instructed to itensify its operation in areas where the
