THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY AND CIVIL SUPPLIES (SHRI B. P. MAURYA) : A statement is laid on the Table of the Ho

Statement

Andaman and Nicobar Islands have been declared as a backward area, eligible for 15% Central capital subsidy. The subsidy has to be disbursed by the Union Territory Administration or its nominee in the first instance; reimbursement claim is then received by the Central Government. No such claim has been received so far.

Improved tools and equipment at 50% subsidised rates are distributed to artisans and small entreneurs-

Financial assistance in the form of loans is given to small scale industrialists under the State Aid to Industries Act, as an incentive for development of small industries. Managerial subsidy is given to industrial cooperatives.

The expenditure on the above schemes of assistance in the last three yerrs has been as follows:
