A recent assessment of the production of coal during 1974-75 has shown that the output during the year may be about 88 million tonnes. Efforts are being made to achieve the earlier target of 90 minion tonnes.

THE MINISTER OF STATE IN THE DEPARTMENT OF PERSONNEL AND ADMINISTRATIVE REFORMS (SHRI OM MEHTA): (a) Yes, Sir, In view of the increase in the upper age limit from 24 years to 26 years for taking the IAS. etc. Examination conducted by the UPSC for recruitment to the higher services and pending examination of the whole system of recruitment to these Services by a Committee appointed under the Union Public Service Commission, the number of chances available to candidates in the Examinations held in 1973 and 1974 was increased to three purely as a transitional measure.

(b) and (c) A decision regarding the number of chances to be a'lowed to candidates taking the Assistant's Grade Examination, as also other Examinations, will be taken after the recommendations of the Committe examining the question with reference to recruitment for higher non-technical Services are available.

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI I. K. GUJARAL): (a) No, Sir, The Indian Institute of Mass Communications conducted a survey among 841 urban educated youth in the towns of Patna, Gaya, Monghyr and Muzaffar-pur. The survey was intended to:

- (i) investigate into the sources of information and channels of communication with youth;
- (ii) analyse the attitudes to or opinion about the youth protest movement; and
 - (iji) study youth participation.
