1385. SHRISUBRAMANIANSWAMY: SHRI V. V. SWAMINATHAN:

Will the Minister of COMMUNICA-TIONS be pleased to state:

- (a) whether it is a fact that Government have decided to allow the transfer of telephone connections; and
 - (b) if so, what are the details thereof?

THE MINISTER OF COMMUNICATIONS (DR. SHANKER DAYAL SHARMA): (a) Yes, Sir.

(b) Under the current rules, a subscriber can lansfer his telephone to an individual, firm or company or ary other organisation at the same premises after atleast 3 years have elapsed since installation. A fee of Rs. 500 will be charged for such transfer. Once a telephone is transferrd, no further transfer will be allowed within 3 years A shift is permitted under shift rules after the transfer has been effected. Telephones given to individuals on priority on special consideration in their personal capacity are not transferable except in the case of death of the original hirer.

Reddy Commission on communal incidents in Ahmedabad, Gujarat

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) to (c) while mentioning about the allegation 61 police officer having deliberately shot two persons, the Reddy Commission observed that there may be some of the instances in which an inquiry may be called for. On the basis of these observations inquiry was held into the matter by the State Government which concluded that the allegation was incorrect.
