THE MINISTER OF STATE IN THE DEPARTMENT OF PERSONNEL AND ADMINISTRATIVE REFORMS (SHRI OM MEHTA): (a) The investigations have not yet been completed.

(b) Does not arise.

### Self-Sufficiency Nuclear Fuel

1403. SHRI AWADHESHWAR PRASAD SINHA: Will the Minister of ATOMIC ENERGY be pleased to state:

- (a) whether Government are taking steps to achieve self-sufficiency in nuclear fuel and Indianisation of nuclear know-how and technology, and
  - (b) if so, what are the details thereof?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) Yes, sir,

(b) Fuel required for the Tarapur Atomic Power Station is slightly enriched uranium oxide. The raw matrial, *i.e.* enriched uranium hexaflouride is being imported and further fabrication to finished fuel is carried out at the Nuclear Fuel Complex, Hyderabad. Our nuclears power programme does not envisage the setting up of further nuclear power plants using slightly enriched uranium as fuel. However, work of development of uranium enrichment technology has also been recently initiated at the Bhabha Atomic Research Centre. As for the fuel required for the CANDU reactors that form the basis of our nuclear power programme, we ar« self-sufficient.

## Proposal to reduce the Posts in Gazetted Cadre in the Posts and Telegraphs Department

1404. SHRI VISWANATHA MENON: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether there is any proposal under Government's consideration to reduce in the Posts and Telegraphs Department the number of posts in the gazetted cadre from the level of the directors and above as a measure of economy; and

THE MINISTER OF COMMUNICATIONS (DR. SHANKER DAYAL SHARMA): (a) No, Sir. However, the position is constantly reviewed and posts not justified are brought under reduction, (b) Does not arise.

A representation of Shri Munshi Ram was received through Mrs. Mukul Banerjee. M. P. about alleged abduction of his daughter Miss Nirmala Kumari from village Jawali Tehsil Nurpui', Distt. Kangra- The matter was referred to the Government of Himachal Pradesh. The State Government intimated that patition-er's daughter Miss Nirmala, aged 20 years was neglected by her step-mother. She became intimate with one Shri Suraj Bhan. This fact was known to her father. On 3rd January, 1974
