Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether it is a fact that a sum exceeding Rs. 2 crores has already been spent tor the Super Tanker Oil Terminal Project at Cochin port;
- (b) whether cost estimates are likely to increase substantially due to delay on the part of the Central Government in according expenditure sanction for the project;
- (c) if so, what steps Government have taken to expedite financial sanctions for the Project ?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMALAPATI TRIPATHI): (a) The Cochin Port has so far spent Rs. 143 lakhs for the Super Tanker Oil Terminal Project.

- (b) The increase in cost estimates of the Project will depend on the trend of prices prevailing in future years.
- (c) The detailed project report prepared by the Consultants is under consideration in consultation with the concerned authorities.

Will the Minister of EXTERNAL AF-FAIRS be pleased to refer to the answer to Unstarred Ouestion 385 given in Rajya Sabha on the 26th July, 1974 and state:

(a) whether it is a fact that most of the Ribats set up by the Indians in Saudi

Super Tanker Oil Terminal Project at Arabia are now in the possession of Saudi Arabian caretakers, who let out accommo-Ribats and utilise the dation in those amount collected for their own purpose:

(b) if so, whether Government propose to take up the matter with the Saudi Alabian Government to ascertain the number of such Ribats and ensure that they are utilised for the purpose for which they were originally constructed ?

THE MINISTER OFEXTERNAL AFFAIRS (SHRI Y. B. CHAVAN) : (a) and (b) The existence of many Ribats, whether they are recognised as Ribats under Indian and Saudi law and whether they may have been endowed or set up by Muslims of India, has been the subject of detailed investigations involving the tracing of ald records and correspondence, exinformation with the Saudi changes of Arabian authorities and other concerned organisations. Under Saudi Arabian law, the Nazirs (Managers) should be Saudi nationals. The primary responsibility for the proper running of such Ribats rests with the heirs of the Indian endowers and their Nazirs in Saudi Arabia. Government for its part seeks to persuade the heirs to ensure the aministrative efficiency these institutions and encourages them to take an active interest in maintaining and utilising them for the purpose they were originally created, in cooperation of the Saudi authorities.

Indo-U.K. relations

THE MINISTER OF EXTERNAL AFFAIRS (SHRI Y. B. CHAVAN):

- (a) Yes, Sir.
- (b) There exists a differences of opinion between the two Governments over India's peaceful nuclear explosion experimet in September, 1974 has proposed a explaining their views. Discussions have also been held between their diplomatic representatives. These are in the nature of confidential exchanges between the two Governments and it is not possible to divulge the details.

Wages fixation for forest labour

- (a) whether it is a fact that the Minimum Wages Central Advisory Board which met in September, 1974 has proposed a minimum wage for forest labour; and
- (b) if so, what are the recommendations made by the Board and what decision Government have taken thereon?

THE MINISTER OF LABOUR (SHRI K. V. RAGHUNATHA REDDY): (a) and (b) The Board approved a proposal sponsored by the Ministry of Labour regarding extension of the Minimum Wages Act, 1948 to forest Labour, as recommended by the National Commission on Labour. This has been brought to the notice of the State Governments, for necessary further acion.
