Accident to Madras-Mangalore Mail

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): (a) and (b) Presumably the reference is to the failure of engine of Madras-Mangalore Mail between Payyanur and Trikarpur stations on 24-10-74. The engine had failed due to defect in the underframe of its tender.

Underframes of engine tenders are adequately strengthened in Shops and intensive examination is carried out in the sheds. The defaulting staff are also taken up.
