Loans to Engineers by Nationalised Banks

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI SUSHILA ROHATGI): (a) and (b) The present arrangements for data flow do not provide for compilation of information separately regarding advances to unemployed engineers or of data relating to number of pending applications. The two broad categories under which advances to unemployed engineers would generally figure are "small scale industries" and "professional and self-employed persons". The available information relating to the number of borrowal accounts covered by the public sector banks in Rajasthan as at the end of June, 1973 and June, 1974, is set out below;
