Statement

Education and particularly school education being a State subject, provision of school facilities in rural areas is primarily the concern of the State Governments. The Minimum Needs Programme incorporated in the draft 5tb Five Year Plan aims at providing adequate educational facilities particularly in rural areas.

2. In accordance with the national policy of providing school facilities to every child within easy walking distance of about 1.5 km the State Governments had undertaken a massive effort to establish schools in rural areas. It was estimated that in 1966 almost 95% of the
