Administration has reported that they have not received any such complaint. According to them, the Fair Price Shop holders are allowed to register upto 6000 cereal units but relaxation has been granted to the Fair Price Shops functioning in Rashtrapati Bhavan and it can register over and above this limit. There is no limit fixed for Kerosene Oil licencees, H. V. Oil licencees and Coal Licencees. Any dealer can register any number of cards with him. The Delhi Administration has also stated that there is no proposal with them to open any new Fair price shop in Rashtrapati Bhavan. So far as opening of a branch of Super Bazar is concerned the Cooperative Store Ltd., (Super Bazar) New Delhi, do not have any proposal to open a branch in the North Avenue. However, a branch of the Super Bazar is functioning close by in Willingdon Hospital premises.
