- (b) Government did not sell any equity of VSNL during the last year. However, Government sold 25per cent equity of VSNL in February 2002 through Strategic Partner route in favour of M/s Panatone Finvest Ltd. (PFL), a Tata Group company, for sum of Rs. 1439.25 crores (7,12,50,000 shares at price of Rs. 202/- per share).
- (c) There is no financial loss suffered by the Government during its disinvestment of 25 per cent stake on 13.02.2002 as the closing price of VSNL shares in the National Stock Exchange on the date of receipt of financial bids *i.e.* 01.02.2002 was Rs. 156.95 per share, as against Rs. 202/- per share price received from the strategic partner.
