

### Corruption Charges against the Punjab Wakf Board

1607. SHRI BHOLA PRASAD : Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state :

(a) whether Government have received a communication from the Secretary of Punjab Wakf Board in April, 1974 containing allegations of corruption and irregularities in the working of Punjab Wakf Board; and

(b) if so, the details thereof, and the action taken thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN) : (a) Yes, Sir.

(b) The communication received from the Secretary, was sent to the Chairman, Punjab Wakf Board, for his comments which have since been received. The matter is under examination.

### Shortage of Drinking Water in Gujarat

(c) the number of persons given work so far under the relief measures programme, Taluka-wise;

(d) the expenditure so far incurred on the relief works, Taluka-wise;

(e) the details of the programme for the whole year for the relief works, Taluka-wise; and

(f) the total estimated cost for the annual programme for relief works, Taluka-wise?

### Gandhi Nagar Town Planning Scheme

(a) whether the Gandhi Nagar Town Planning Scheme was sanctioned;

(b) how much land has been acquired for this scheme and the year of acquisition; and the estimated cost of the scheme;

(c) the expenditure incurred for implementation and execution of the scheme uptill now, year-wise;

(d) the expenditure incurred uptill now under the scheme;

(e) the revised estimated cost of the said scheme; and

(f) by when the scheme is likely to be completed?
