THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PRANAB MUKHERJEE: (a) and (b) Existing orders provide that the overtime earnings of office staff and other staff, whose hours of work and nature of ducties are comparable to those of office staff, should nol exceed 1 /3rd of their emoluments. monthly In special circumstances, the per-sonnel staff are allowed overtime earnings, not exceeding 50 per cent of their monthly emoluments, provided that thei: officers certify that they had satisfied themselves that the payment in excess of 1/3rd ceiling, but not exceeding 50 per cent, was necessary in the public interest.

(c) As detention of employees on over-lime work is resorted to only in cases oi urgency of work and as arrangements have necessarily to be made to meet such situations, it is not possible to issue instructions not to detain employees beyond a certain limit.
