

**Houses for the coal miners**

1790. SHRI S. W. DHABE: Will the Minister of ENERGY be pleased to state:

(a) whether there is a proposal under Government's consideration for providing housing facilities to the coal miners working under the Coal Mines Authority during the Fifth Five Year Plan; and

(b) if so, how many houses are built for the workers till now since the mines were taken over by the Coal Mines Authority?

THE DEPUTY MINISTER IN THE MINISTRY OF ENERGY (PROF. SIDDHESHWAR PRASAD): (a) and (b). Yes, Sir. A Five Year Plan for the construction of houses has been prepared by Coal Mines Authority. The information regarding the total number of houses built so far after nationalisation is being collected and will be placed on the Table of the House.

**Expansion programme of T.V. during Fifth Plan**

(a) what is the television expansion programme during the Fifth Five Year Plan; and

(b) whether Nagpur and Aurangabad are included in the programme?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA): (a) TV Stations at Delhi, Bombay (with Relay Centre at Poona), Srinagar and a transmitting station at Amritsar are already functioning. TV Stations are also

being set up at Madras, Lucknow (with a Relay Centre at Kanpur), Calcutta (with two Relay Centres near Midnapur and Asansol) and Jullundur (with a Relay Centre at Kasauli) as part of the Fourth Five Year Plan.

In addition, subject to availability of funds, three programme originating TV Stations at Patna, Cuttack and Hyderabad and a few relay Centres attached to them are also proposed to be set up as part of the Fifth Plan to provide continuity of TV Service to areas, which will be served by the Satellite Instructional Television Experiment.
